The Mayor and Common Council convened in open session in the Municipal Building at 215 Stiger Street, Hackettstown, New Jersey at 7:00 PM on August 9, 2018. The meeting opened with a salute to the Flag.

Bill Lerman, Hackettstown realtor, spoke about the proposed CCO ordinance, which is under consideration by the Town for adoption.

Debbie Sayer, Exit Realty, spoke concerning her thoughts on the CCO ordinance.

WHEREAS, the property owners failed to remove the debris, brush and obnoxious growth within ten days of their receipt of the notice; and

WHEREAS, the Department of Public Works has caused the debris, brush and obnoxious growth to be removed; and

WHEREAS, the Director/Superintendent of the Department of Public Works has certified to the Mayor and Common Council the cost of the removal of the debris, brush and obnoxious growth.
