

## **ORDINANCE 2025-06**

### **ORDINANCE OF THE TOWN OF HACKETTSTOWN AMENDING CHAPTER 13, ARTICLE 2, SECTION 13-12, SCHEDULE XII OF THE TOWN CODE (NO STOPPING OR STANDING) TO INCLUDE MORGAN TERRACE'S NORTHSIDE CURB**

**WHEREAS**, the Town of Hackettstown (the "Town") is a municipal corporation of the State of New Jersey; and

**WHEREAS**, Chapter 13, Article 2, Section 13-12 (Schedule XII) of the General Ordinances ("Code") of the Town currently list the streets or parts of streets where no person shall stop or stand a vehicle between the hours specified; and

**WHEREAS**, the Mayor and Common Council have determined it would be beneficial to include Morgan Terrace's northside curb in Chapter 13, Article 2, Section 13-12 (Schedule XII); and

**WHEREAS**, in furtherance of the foregoing, the Town must update Schedule XII of Chapter 13, Article 2, Section 13-12 of the Code to identify same.

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Common Council of the Town of Hackettstown that Chapter 13, Article 2, Section 13-12 Schedule XII of the Code shall be amended to **add** the following to the list of existing locations:

#### **SECTION I**

#### **SCHEDULE XII**

In accordance with the provisions of Section 13-12, no person shall stop or stand a vehicle between the hours specified upon any of the following described streets or parts of streets:

<u>Name of Street</u>	<u>Hours</u>	<u>Location</u>
<u>Morgan Terrace</u>	2 PM to 3:30 PM on school days	Morgan Terrace's northside curb (bordering 328 Hurley Drive) from the intersection of Hurley Drive, proceeding 213 feet West

## **SECTION II. REPEALER**

It is the intent of the Mayor and Common Council of the Town of Hackettstown to incorporate the additions, amendments and/or supplements contained in this Ordinance into the Code. All of the remaining provisions in Chapter 13, Article 2, Section 14-19 Schedule XV of the Code shall remain unchanged and have full force and legal effect. All other resolutions and ordinances governing parking on Town streets enacted and inconsistent herewith are hereby modified pursuant to the terms of this Ordinance.

## **SECTION III. EFFECTIVE DATE:**

A copy of this Ordinance shall be available for public inspection at the offices of the Town Clerk.

Notice is hereby given that the aforesaid ordinance was introduced at a regular meeting of the Common Council of the Town of Hackettstown, County of Warren, State of New Jersey, held on June 12, 2025, and that a regular meeting of the same to be held on July 10 2025 at the Municipal Building, 215 West Stiger Street, Hackettstown, New Jersey, at the hour 7:00 o'clock in the evening, the said Common Council will consider the final passage of said ordinance.
