**AN ORDINANCE OF THE TOWN OF HACKETTSTOWN  
AMENDING SCHEDULE I OF CHAPTER 13 (ENTITLED "TRAFFIC AND  
PARKING") OF THE TOWN ORDINANCES PROHIBITING PARKING ON  
MITCHELL ROAD BETWEEN VICTORIA LANE AND JAMES COURT**

**WHEREAS**, parking is currently prohibited on certain streets as listed in Schedule I of Chapter 13 in the Town of Hackettstown; and

**WHEREAS**, via Ordinance 2019-2 the Council prohibited parking on the south side of Mitchell Road between the intersection with Arthur Terrace and the intersection with Victoria Lane; and

**WHEREAS**, the Council, in the interests of public safety and order, wish to extend the parking prohibition on Mitchell Road so that it will be prohibited on the south side from the northerly intersection with Arthur Terrace to James Court in accordance with the below measurements.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Common Council of the Town of Hackettstown, County of Warren, State of New Jersey, as follows:

**Section One:** Pursuant to Section 13-7 of the Town Code, entitled "Parking Prohibited at All Times on Certain Streets", Schedule I of Chapter 13 is hereby amended by the insertion of the following:

<u>Name of Street</u>	<u>Sides</u>	<u>Location</u>
Mitchell Road	South	Between the northerly intersection with Arthur Terrace and James Court

**Section Two:** The Town may designate the above No-Parking Zones by painting the curb yellow and/or posting signs.

**Section Three:** If any section, subdivision, paragraph, clause, or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to such section, subdivision, paragraph, clause, or provision and the remainder of this ordinance shall be deemed valid and effective. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

**Section Four:** This ordinance shall become effective upon final passage and publication according to law.
