**AN ORDINANCE OF THE TOWN OF HACKETTSTOWN
AMENDING SCHEDULE I OF CHAPTER 13 (ENTITLED "TRAFFIC AND
PARKING") OF THE TOWN ORDINANCES**

WHEREAS, parking is currently prohibited at all times on certain streets as listed in Schedule I of Chapter 13 in the Town of Hackettstown; and

WHEREAS, the Council, in the interests of public safety and order, wish to prohibit parking within 50' of intersections adjacent to Hackettstown Middle School, in accordance with the below schedule.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Common Council of the Town of Hackettstown, County of Warren, State of New Jersey, as follows:

Section One: Pursuant to Section 13-7 of the Town Code, entitled "Parking Prohibited at All Times on Certain Streets", Schedule I of Chapter 13 is hereby amended by the insertion of the following:

<u>Name of Street</u>	<u>Sides</u>	<u>Location</u>
Washington Street feet	West	From the intersection with West Plane Street to a point 50 north. From the intersection with Center Street to a point 50 feet south.
	East	From the intersection with Center Street to a point 50 feet north, and to a point 50 feet south.
Madison Street feet	West	From the intersection with West Plane Street to a point 50 north, and to a point 50 feet south. From the intersection with Center Street to a point 50 feet North, and to a point 50 feet south.
	East	From the intersection with Center Street to a point 50 feet North, and to a point 50 feet south.

Section Two: The Town shall install proper signage so advising the public.

Section Three: If any section, subdivision, paragraph, clause, or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to such section, subdivision, paragraph, clause, or provision and the remainder of this ordinance shall be deemed valid and effective. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

Section Four: This ordinance shall become effective upon final passage and publication according to law.

Notice is hereby given that the aforesaid ordinance was introduced at a regular meeting of the Common Council of the Town of Hackettstown, New Jersey, November 21, 2022, and that at a regular meeting of the same to be held on December 8, 2022 at the Municipal Building, 215 Stiger Street, Hackettstown, New Jersey, at the hour of 7:00 p.m., the said Common Council will conduct a public hearing and will consider the final passage of said ordinance.
