

ORDINANCE # 2022-06

AN ORDINANCE APPROPRIATING THE TOTAL SUM OF \$637,800 FOR THE FUNDING OF VARIOUS CAPITAL IMPROVEMENTS OR PURPOSES BY THE TOWN OF HACKETTSTOWN, IN THE COUNTY OF WARREN, NEW JERSEY.

BE IT ORDAINED AND ENACTED by the Mayor and Council of the Town of Hackettstown, County of Warren, New Jersey, as follows:

Section 1. The sum of \$637,800 is hereby appropriated for the following purposes:

- 1) \$155,800 for Road resurfacing and repair projects, including but not limited to, portions of Washington Street, Warren Street, and Bell's Lane.
- 2) \$200,200 for Grand Avenue Road Improvement Project
- 3) \$42,000 for purchase of a field tractor with drag, and replacement of light poles at Art Sheldon Pool field for Recreation
- 4) \$3,000 for replacement of Community Center restroom partitions
- 5) \$47,000 for purchase of a 4x4 pickup truck with plow for DPW
- 6) \$36,000 for purchase of Fire Department protective gear, SCBA bottle replacement, and hose and ladder replacement
- 7) \$67,000 for purchase of radios for Police Department
- 8) \$82,000 for purchase of radios for Fire Department
- 9) \$4,800 for purchase of SDL software for Fire Prevention Office

Section 2. The funding sources for said ordinance are as follows:

- 1) Capital Improvement Fund \$468,600
- 2) State of NJ DOT Grant Receivable Grand Avenue \$169,200

Section 3. In connection with the amount authorized in Section 1 hereof, the Town makes the following determination:


- a) The purposes described in Section 1 hereof is not a Current Expense and is an improvement, which the Town of Hackettstown may lawfully make as a general improvement.
- b) The period of usefulness of the purpose described in section 1 hereof is, at a minimum, five (5) years as required under the Local Public Bond Law.

Section 3. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provisions so adjudged and the remainder of the ordinance shall be deemed valid and effective.

Section 4. This ordinance shall become effective immediately upon final passage, approval, and publication as provided by law.

Notice is hereby given that the aforesaid ordinance was introduced at a regular meeting of the Common Council of the Town of Hackettstown, New Jersey, held on April 14, 2022, and that a regular meeting of the same to be held on May 12, 2022 at the Municipal Building, 215 Stiger Street, Hackettstown, New Jersey, at the hour 7:00 o'clock in the evening, , the said Common Council will consider the final passage of said ordinance.


