NOW, THEREFORE, BEIT RESOLVED on this 4th day of May, 2020 by the Mayor and Common Council of the Town of Hackettstown that the Tax Collector is hereby authorized and empowered, pursuant to Executive Order 130 as signed by Governor Philip D. Murphy to extend the grace period for the second quarter 2020 property taxes to the end of business on June 1, 2020.
