#### Resolution

WHEREAS, Allentown SMSA Limited partnership d/b/a/ Verizon Wireless, ("Verizon Wireless"), is a provider of commercial mobile service subject to regulation by the Federal Communications Commission; and

WHEREAS, Verizon Wireless has entered into agreements with parties that have the lawful right to maintain poles in the public right-of-way pursuant to which Verizon Wireless may use such poles erected within the public right-of-way into the Town of Hackettstown; and

WHEREAS, New Jersey law permits such use provided that there is the consent of the relevant municipality;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF HACKETTSTOWN, COUNTY OF WARREN, STATE OF NEW JERSEY THAT:

- 1. Permission and authority are hereby granted to Verizon Wireless and its successors and assigns, to use poles erected by parties that have the lawful right to maintain poles within the public right-of-way in the Town of Hackettstown, subject to the following:
  - A. Verizon Wireless, and its successors and assigns, shall adhere to all applicable Federal, State, and Local laws regarding safety requirements related to the use of the public right-of-way.
  - B. Verizon Wireless, and its successors and assigns, shall comply with all applicable Federal, State and Local laws requiring permits prior to beginning construction, and shall obtain any applicable permits that may be required by the Town of Hackettstown.
  - C. Such permission be and is hereby given upon the condition and provision that Verizon Wireless, and its successors and assigns, shall indemnify, defend and hold harmless the Town of Hackettstown, its officers, agents, and servants, from an y claim of liability or loss or bodily injury or property damage resulting from or arising out of the acts or omissions of Verizon Wireless or its agents in connection with the use and occupancy poles located within the public right-of-way, except to the extent resulting from the acts or omissions of the Town of Hackettstown.
  - D. Verizon Wireless shall, at its own cost and expense, maintain commercial general liability insurance with limits not less than \$1,000.000 for injury to or death of one or more persons in any one occurrence and \$500,000 for damage or destruction to property in any one occurrence. Verizon Wireless shall include the Town of Hackettstown as an additional insured.
  - E. Verizon Wireless shall be responsible for the repair of any damage to paving, existing utility lines, or any surface or subsurface installations, arising from its construction, installation or maintenance of its facilities.
  - F. Notwithstanding any provision contained herein, neither the Town of Hackettstown

nor Verizon Wireless shall be liable to the other for consequential, incidental, exemplary, or punitive damages on account of any activity pursuant to this instrument.

- G. This instrument shall be adopted on behalf of the Town of Hackettstown by the Town Council of the Town of Hackettstown and attested to by the Town of Hackettstown Clerk who shall affix the Town of Hackettstown Seal thereto.
- H. The permission and authority hereby granted shall continue of the same period of time as the grant to parties whose poles Verizon Wireless is using.
- I. This Resolution is contingent upon execution of a Rights-of-Way Use Agreement as between the Town of Hackettstown and Allentown SMSA Limited Partnership d/b/a/ Verizon Wireless.

WHEREAS, the Municipal Council of the Town of Hackettstown thereafter designated the Property as "an Area in need of Redevelopment" by Resolution adopted on October 27, 2016 and authorized the Planning Board of the Town of Hackettstown to prepare a Redevelopment Plan for the Property; and

WHEREAS, the Planning Board of the Town of Hackettstown caused the Town Planner, John Madden, AICP, PP, of Maser Consulting, P.A., to prepare a Redevelopment Plan for the Property located at Block 125, Lot 9.01 (the "Redevelopment Plan"); and

WHEREAS, the Planning Board of the Town of Hackettstown reviewed the Redevelopment Plan, providing comments and suggested changes to its professional staff; and

WHEREAS, at its meeting on January 24, 2017, the Planning Board of the Town of Hackettstown reviewed the Redevelopment Plan for Block 125, Lot 9.01, 301 Mountain Avenue prepared by John Madden AICP, PP of Maser Consulting P.A., dated January 11, 2017 and adopted a Resolution recommending that the Redevelopment Plan be adopted by the Municipal Council; and

WHEREAS, on February 23, 2017, the Municipal Council adopted an ordinance of the Town of Hackettstown adopting the Redevelopment Plan pursuant to the Local Redevelopment and Housing Law, NJSA 40A:12A-1, et seq.; and

WHEREAS, the Town now desires to designate 2016 Mountain Hackettstown, LLC, or such affiliate thereof as may be deemed appropriate by 2016 Mountain Hackettstown, LLC, as the Redeveloper ("Redeveloper") of the Property, subject to the condition that the Town and Redeveloper enter into a Redevelopment Agreement pursuant to governing law to provide for the redevelopment of the Property.

NOW, THEREFORE, BE IT RESOLVED BY THE Municipal Council of the Town of Hackettstown, County of Warren, State of New Jersey, as follows:

- 1. The aforementioned recitals are incorporated in their entirety as through set forth at length herein.
- 2. 2016 Mountain Hackettstown, LLC is hereby designated as the Redeveloper of the Property, subject to execution of a Redevelopment Agreement.
- 3. This Resolution shall take effect in accordance with applicable law.
