Dear Mayor and Council,

Colliers Engineering & Design ("CED") is pleased to submit the following proposal for professional engineering services to assist the Town in the design and construction phases of the East Baldwin Street Improvement Project. The proposal includes the scope of work, the required fees, a list of items that must be addressed by the Town, and a list of exclusions.

An application was filed by the Town in 2020 with the New Jersey Department of Transportation to obtain monies from the municipal aid portion of the Transportation Trust Fund to improve East Baldwin Street between Main Street and East Prospect Street.

On November 16, 2020, the Town was informed that the NJDOT had awarded a grant in the amount of \$121,700.00 for the project.

In order to move the project into construction, the Town will have to submit certain engineering documents to the NJDOT's Local Aid Office in Mt. Arlington, New Jersey in order to obtain approval to construct the project.

The following scope of services is proposed:

#### Scope of Work

#### 1.0 Design Phase

Since the Town plans on either performing some of the required work through its Public Works Department or utilizing South State Inc. through its membership in the Morris County Cooperative Pricing Council ("MCCPC"), a very basic engineering plan set that includes a maintenance and protection of traffic plan, a typical roadway cross-section, and typical details and notes is acceptable to the NJDOT. Detailed engineering plans with grades and elevations, planimetrics, and other features are not needed on milling and paving projects involving MCCPC contractors.

Maser Consulting is now Colliers Engineering & Design



The following tasks are proposed under this phase:

- 1.01 Prepare an engineering plan consisting of a maintenance and protection of traffic plan, typical roadway cross-sections, and typical construction details and notes.
- 1.02 Prepare technical specifications and bid documents.
- 1.03 Prepare construction cost estimates.
- 1.04 Prepare engineer's certification.
- 1.05 Submit the documents prepared in Tasks 1.01 1.04 above to the NJDOT.
- 1.06 Once the documents in Tasks 1.01 1.04 are approved by the NJDOT, prepare a resolution of award of contract for approval by the Town Council for South State Inc.
- 1.07 Submit adopted resolution of award to the NJDOT to obtain authorization for the Town to commence construction on the project.
- 1.08 Prepare and submit invoice to the NJDOT to obtain 75% of the grant proceeds from the NJDOT upon approval of the resolution submitted as part of Task 1.07.

#### 2.0 Construction Phase

- 2.01 Schedule a preconstruction conference with South State Inc. and other involved parties.
- 2.02 Issue minutes of the preconstruction conference following the completion of the meeting.
- 2.03 Obtain and review Material Questionnaire ("MQ") from South State Inc. Upon approval, forward the approved MQ to the NJDOT.
- 2.04 Perform a post- construction site visit to ensure that the work was performed in accordance with the approved plans.
- 2.05 Prepare close-out and reimbursement package for the project following the completion of construction. Submit close-out and reimbursement package to the NJDOT upon completion.

#### Fee Proposal

All services on this contract shall be performed in accordance with the terms and provisions in the contract between the Town of Hackettstown and CED for municipal engineering services for the 2021 calendar year. The total lump sum fee for the services described above is as follows:

The above fee includes an allowance of \$200.00 for printing and reproduction and other reimbursable expenses.

#### Items to be Addressed by the Town

- 1. The Town shall provide CED with access to files and allow relevant documents to be utilized.
- 2. The Town shall permit representatives of CED to visit the work sites to collect information.
- 3. The Town will coordinate with South State Inc. and DPW in the scheduling and performance of the work on East Baldwin Street.
- 4. The Town will review and process South State Inc. invoices for payment.
- 5. The Town will provide CED with invoices and cancelled checks from contractors to allow for the preparation of the documents for close-out and final reimbursement.

#### Clarifications/Exceptions

The following services are excluded from the scope of work:

- 1. Field survey work.
- 2. The preparation of bid documents for a multi-phase project.
- 3. Printing and reproduction costs over and above that allowed for in this contract.
- 4. Any other exclusions previously referenced in the proposal.
