Subject: **Outdoor Dining – Temporary Zoning Permit**

Dear Main Street Retail Food Service Establishments,

The Town of Hackettstown adopted Ordinance 2019-07 containing Section 527 Outdoor Dining on Public Sidewalks along Main Street within the TCC Zone District on the 8th day of August 2019.

The required Temporary Zoning Permit and the associated Outdoor Dining Plan was to commence this year, 2020. The Temporary permit may be issued for a period of up to one (1) year beginning April 15th.

Due to the unforeseen situation, the application process has been on hold. As the Town of Hackettstown looks forward to the reduction of restrictions associated with our restaurants and eateries, those retail food service establishments on Main Street that look to participate in the Outdoor Dining shall complete and apply for the Temporary Zoning Permit.

The Mayor and Council have waived all fees associated with the Outdoor Dining Application for this Outdoor Dining season.
