 12 square feet or less 	\$20.00

 Banners permitted under special events permit 	No Fee

Grand Opening Banner(s)

No permit required provided business is an approved use, i.e., has obtained a Zoning Permit

- Permitted for 90 consecutive days
- Maximum three (3) pennants, maximum 25 square feet
- Attached to building or associated railings / wall

Promotional Banner

Permit required with associated fee as to maximum square footage

- Permitted <u>90 calendar days</u> in any calendar year
- Maximum one (1) banner per promotion
- Attached against building or front railings

It shall be noted that a \$50.00 commercial fee will be charged for any resubmittal / amended zoning application or work commenced / done without prior zoning approval.
